I understand and acknowledge that:

1. Title to and ownership of the Data (defined as the Product in the Data Agreement) and any modifications made thereto will at all times remain with The City.
2. The Data is provided to me for **educational use only and is to be used exclusively for instruction and academic research** and is not be used for any other purposes.

3. I will not copy, sell, loan, lease, distribute, transfer or sublicense the Data, nor authorize or allow any party to duplicate or reproduce the Data, in whole or in part, in any form or format whatsoever.

4. If I wish to publish any work derived from the use of the Data in journals etc. I will provide to The City, for its review and commentary, one (1) copy of any proposed publication that incorporates the Product at least thirty (30) days in advance of the date of a proposed disclosure. If The City does not object in writing to such disclosure within thirty (30) days of its receipt, the Licensee shall be free to proceed. In the event written objection is made by The City and those objections are reasonable, The City and the Licensee shall negotiate a reasonable and acceptable version of the proposed disclosure within the original thirty (30) day notice period.

5. I will make all efforts to ensure the data is secure from direct access by third parties and I will not share the data outside of the terms of this license unless I obtain permission from The City to do so.

6. I will not use the Data in the pursuit of any commercial or income-generating activity.

7. I acknowledge that the Data is provided on an “as is” basis and neither The City nor the Licensee make any guarantees, representations or warranties respecting the Data, either expressed or implied, arising by law or otherwise, including but not limited to, effectiveness, completeness, accuracy or fitness for a particular purpose.

8. I understand that The City has the right to audit my use of the Data to determine whether or not the provisions of the Data Agreement have been complied with.

9. I understand that I must return the Data or certify it has been destroyed if the use for the Data no longer meets this Data Release Agreement; if I am no longer affiliated with the Licensee; or in the event the Data Agreement with The City should terminate.

10. I acknowledge that accessing this data requires the approval of a faculty member at the University of Calgary. If I am not a faculty member, I have informed a sponsoring faculty member, such as a supervisor or class instructor that I am requesting this data.
